

UNIQUE SUPERANNUATION IDENTIFIERS

All Australian Prudential Regulation Authority (APRA) regulated superannuation funds have their own Unique Superannuation Identifier (USI) that's used to identify individual super funds and specific super fund products.

For employers, the USI is used via SuperStream to ensure that contributions are being paid to the right super fund or super product for an employee.

Sometimes the USI of a super fund or product may change. For example, when two super funds merge, or when a super fund or product closes.

Getting the right USI

Some super funds may have more than one USI. For example, following the merger between Cbus Super and Media Super, we now have two different USIs.

Fund members	Unique Superannuation Identifier (USI)

Media Super for all Media Super members	75 493 363 262 002

Why it's important to use the correct USI

It's important that you use the correct USI to pay your employees' contributions based on which super fund or product they are with.

If you pay their contributions using the incorrect USI, a new account may automatically be opened which will result in your employee having two super accounts. This means your employee will pay two lots of administration fees and possibly two lots of insurance premiums.

The impact on insurance

Paying contributions to the incorrect USI may also impact any insurance your employee has.

For example, if a member doesn't receive an on-time compulsory super payment, any insurance cover they have may stop.

What to do if you've used the incorrect USI

Contributions paid under the incorrect USI will need to be refunded so you can resubmit the contributions under the correct USI.

To refund your contributions as soon as possible, you'll need to provide us with your bank account details. Once we have your details, your refund will then take approximately five business days.
